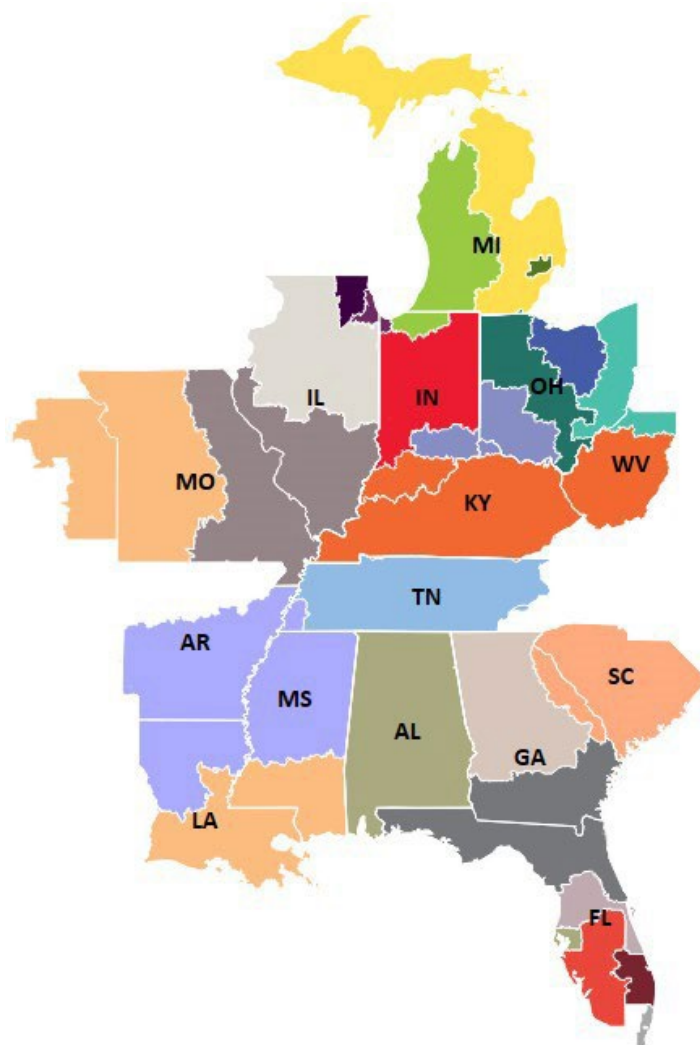


Territory map
